**Medical**—Provide abortion reversal services to women who have started the abortion pill process, regret their decision, and desire to rescue their pregnancy.

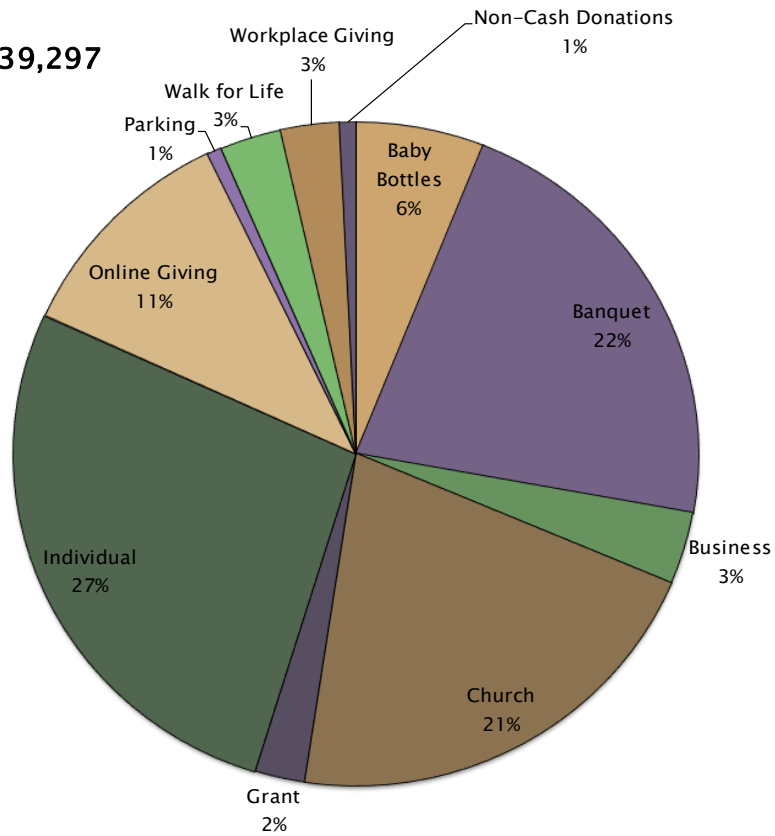
**Client Services**—Expand Just for Guys to establish the importance of the father's influence in pregnancy decisions.

**Outreach**—Expand and build relationships with churches to serve women and men facing pregnancy decisions.

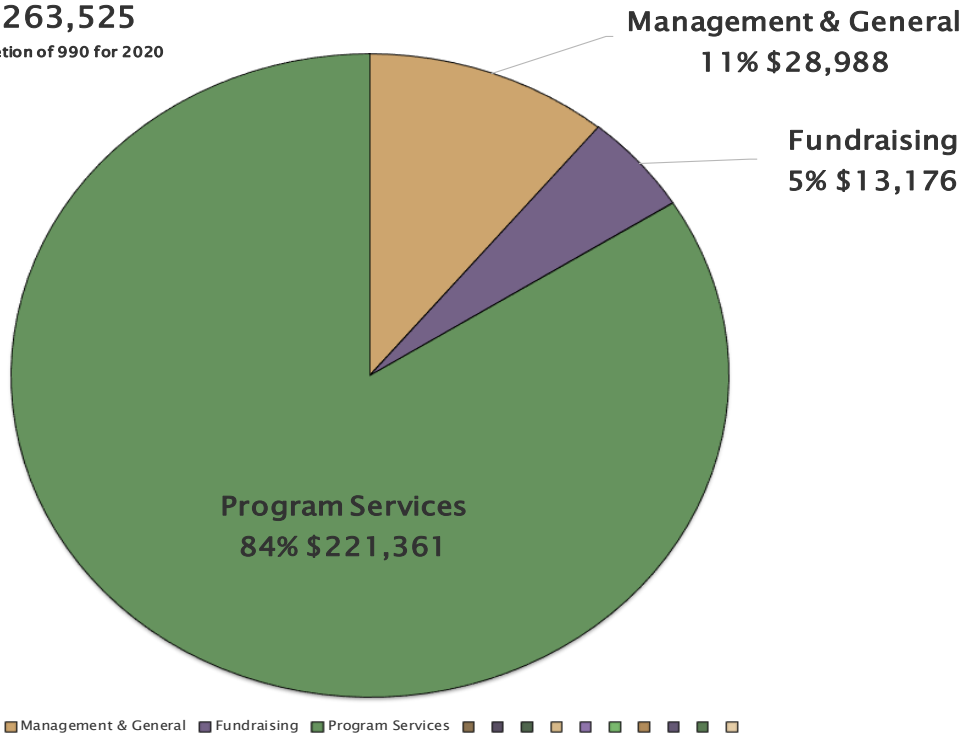
**Center**—Emphasize spiritual strategies for the center.
